#### **Associate Members**

Over the past decades, we have invited associate members (residents outside the deeded lake rights area) to join in our association for the summer months.

Over the past several years interest has decreased and we are seriously considering discontinuing the associate membership program for the foreseeable future.

The downside to discontinuing the program is that we will take in less revenue to support the beach and lifeguards. On the other hand, without the associate memberships on our rolls, we will no longer be considered a public access beach and will not be required to post lifeguards in order for our main membership to use the beach property for swimming or other activities.

Come to the meeting if you would like to have input on this decision or hear the discussion. It is a large change in how we manage the TEA and we would like as much input as possible.

Note: If you have a boat without a sticker or valid current membership, it will be removed from the TEA boat storage lot and sold. Don't let that happen!

# Dock Approval Committee

During the summer of 2014, a joint committee was formed between the TEA, TLPOA, and Vreeland properties to grant dock approvals for Lake Truesdale.

In order to have a dock approved by the **Truesdale Lake Dock Committee** (TLDC) the dock must meet minimum standards outlined on the lake website here:

http://truesdalelake.com/docks/.

The TLDC gives approvals or denials and then passes its decisions on to the town wetland commissioner and building department.

Without the **TLDC** approval, a homeowner will not get approval from the Town of Lewisboro to build or repair their dock.

The guidelines are - for the most part - common sense. There is a requirement to show proof of septic pumping in the past 18 months before any approval will be granted.
